

## **CARLING CURRIE CUP COMPETITION TERMS AND CONDITIONS**

### **TERMS AND CONDITIONS: CARLING CURRIE CUP FINAL COMPETITION:**

#### **1. GENERAL ENTRY CONDITIONS**

1.1 The competition starts on Friday, 4 February 2022 and closes at 24:00 pm SAST on Saturday, 11 June 2022. No late entries will be accepted.

1.2 The competition is open to South African residents only.

1.3 Participants must be over the age of 18 years.

1.4 Participants have to possess a valid ID.

1.5 Participants must be available/contactable on 25 June 2022.

1.6 The following persons are excluded from this competition and may not participate

1.6.1 a director, member, partner, employee or agent of, or consultant to South African Rugby Union ("SA RUGBY"),

1.6.2 a supplier of goods or services in connection with this competition;

1.6.3 the spouses, life partners, business partners or immediate family members of the parties referred to in 1.6.1 and 1.6.2.

#### **2. HOW TO ENTER AND WINNER SELECTION**

This competition will be conducted via Facebook, Twitter, TikTok and Instagram ONLY and starts on the 4 February 2022.

2.1. All participants must follow The Currie Cup Facebook page, The Currie Cup Twitter Page, and our Currie Cup Official Instagram account.

2.2. All participants are expected to regularly post on the mentioned social media platforms using the #ChampionsChallenge hashtag and tagging the above-mentioned handles on the relevant account. The participant who has the most popular posts and engagement (subject to SA Rugby sole decision) throughout the campaign will be added to a list of finalists where a randomiser tool will be used to

select winners (subject to SA Rugby's final decision). Five Participants will be selected via this process.

- 2.3. By entering the Competition, the participant explicitly agrees to be bound by the Competition terms and conditions.
